

# INVITATION FOR NEGOTIATED PROCUREMENT DUE TO TWO-FAILED BIDDINGS

## CILO 2021-019 REPAIR AND REPLACEMENT OF VARIOUS DOOR LOCKSET, DOOR CLOSER AND DOOR HINGES AT ILOILO INTERNATIONAL AIRPORT

1. The **Civil Aviation Authority of the Philippines Iloilo International Airport** intends to procure **Repair and Replacement of Various Door Lockset, Door Closer and Door Hinges at Iloilo International Airport** with the Approved Budget for the Contract (ABC) of **Three Hundred Eighty Four Thousand Four Hundred Seventy Eight Pesos & 71/100 (P 384,478.71)**.
2. The **CAAP Iloilo International Airport**, through its Bids and Award Committee (BAC), now invites technically, legally, and financially capable suppliers for the said **Repair and Replacement of Various Door Lockset, Door Closer and Door Hinges at Iloilo International Airport**.
3. The procurement procedure for this requirement is Negotiated Procurement pursuant to Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of the Republic Act (R.A.) No. 9184, otherwise known as the “Government Procurement Reform Act”, including Annex H thereof.

3. Bidders must quote for all the items.
