



Invitation to Bid for

REPAIR/REPAINTING OF AIRCRAFT MOVEMENT AREAS MARKERS AND MARKINGS AT LAGUINDINGAN AIRPORT

1. The *Civil Aviation Authority of the Philippines*, through the CAAP Corporate Budget 2021 intends to apply the sum of **ONE MILLION SIX HUNDRED TEN THOUSAND PESOS ONLY (Php 1,610,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **REPAIR/REPAINTING OF AIRCRAFT MOVEMENT AREAS MARKERS AND MARKINGS (Bid No. AX-2021-003)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Civil Aviation Authority of the Philippines – LAGUINDINGAN AIRPORT, AREA CENTER X** now invites bids for the above Procurement Project. Completion of the Works is required **SEVENTY-FIVE [75] Calendar Days** Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive e bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **BAC Office, 2nd Floor, CFR Building, Civil Aviation Authority of the Philippines, Laguindingan Airport, Laguindingan Misamis Oriental** and inspect the Bidding Documents at the address given below from 8:00am-4:00pm Monday-Friday.
5. A complete set of Bidding Documents may be acquired by interested bidders on **July 28, 2021 and until the deadline of submission of bid** from given address and website/s below: *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (5,000.00) plus 12% of VAT per RA 10963 otherwise known as Law) TAX Reform for Acceleration and Inclusion (TRAIN issued by Jim C. Sydiongco, CAAP Director General effective 16 October 2019* .The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The Civil Aviation Authority of the Philippines – Laguindingan Airport will hold a Pre-Bid Conference¹ on **August 5, 2021, 9:00AM** at CAAP Laguindingan Airport Conference Room (PMO Building) and/or through video conferencing *via Google*

¹ May be deleted in case the ABC is less than One Million Pesos (Php1,000,000) where the Procuring Entity may not hold a pre-bid conference.

Meet (Please coordinate with BAC Secretariat prior to the schedule of Pre-Bid for the Google Meet link) which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before **August 17, 2021, 9:00AM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **August 17, 2021 at 9:30AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Civil Aviation Authority of the Philippines – Laguindingan Airport reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


