The Civil Aviation Authority of the Philippines (CAAP), Area Center V, Legazpi Airport intends to apply the estimated amount of **One Hundred Thirty Eight Thousand Seven Hundred Ninety Pesos & 30/100 (Php 138,790.30)** for the **Emergency Relocation & Installation Of VSAT Antenna From Legazpi Airport To BIA Including Construction Of Antenna Base Pad & Installation Of Raceway & Other Works**.

The CAAP now requests you to submit price quotation on the item listed below, subject to the Specification and Terms and Conditions provided hereunder.

1. All entries must be printed.
2. Number of days to complete: Fifteen (15) calendar days including unworkable days.
3. Bid must be complete and award will be made on a lump sum basis.
4. Price validity shall be for a period of One Hundred Twenty (120) calendar days.
5. The following should be submitted together with the quotation:
 - 5.1 Valid PCAB License Small A;
 - 5.2 Current Mayor's/Business Permit;
 - 5.3 Phil-GEPS Registration Number;
 - 5.4 Name/credentials of proposed Foreman; and
 - 5.5 List of Contractor's Equipment (one bagger mixer and minor tools & equipment);
The contractor's major equipment units, which are owned, leased, and/or under purchase agreements must be supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, which must meet the minimum requirements.
6. Other documentary requirements:
 - 6.1 Omnibus Sworn Statement (*see attached format, maybe submitted together with the quotation or before issuance of Notice of Award*); and
 - 6.2 Additional Requirements to be submitted *before issuance of Notice To Proceed*:
 - 6.2.1 Work Schedule;
 - 6.2.2 PERT/CPM;
 - 6.2.3 S-Curve;
 - 6.2.4 Manpower Schedule;
 - 6.2.5 Work Method;
 - 6.2.6 Equipment Utilization Schedule;
 - 6.2.7 Construction Safety & Health Programs Approved by the DOLE* ; and
 - 6.2.8 Performance Security.

**Copy of the CSHP received by the DOLE may be initially submitted together with the NOA, however, the DOLE approved CSHP must be immediately submitted upon approval.*

Quotations not accompanied by current Mayor's/Business Permit; valid PCAB License; name/credentials of proposed Foreman; List of Contractor's Equipment with corresponding proof of ownership/certification of availability; and Phil-GEPS Registration Number shall be automatically disqualified.

Prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded.

Quotations must be delivered to the address below not later than **15 September 2021 at 2:00 p.m.** at the BAC Office/Conference Room, G. F. Control Tower Building, Legazpi Airport, Legazpi City.

Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late quotations shall not be accepted.
