RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPAIR AND MAINTENANCE OF BMS, CMS AND ACS AT ILOILO INTERNATIONAL AIRPORT
