**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND
RECOMMENDING APPROVAL FOR THE RENOVATION OF EXCLUSION ROOM
AT GROUND FLOOR ARRIVAL AREA AT ILOILO INTERNATIONAL AIRPORT**
