Section I. Invitation to Bid

SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF VIDEO SURVEILLANCE SYSTEM PROJECT FOR CAAP 16 AIRPORTS IN LUZON AND VISAYAS **BID NO. 19 – 052 – 10**

1. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP), through its Corporate Operating Budget (COB) for CY 2019 intends to apply the sum of **ONE HUNDRED TWENTY NINE MILLION EIGHT HUNDRED SEVENTY FIVE THOUSAND PESOS (Php129,875,000.00)**, inclusive of VAT, being the Approved Budget for the Contract (ABC) to payment under the contract for the **SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF VIDEO SURVEILLANCE SYSTEM PROJECT FOR CAAP 16 AIRPORTS IN LUZON AND VISAYAS (Bid No. 19 – 052 – 10)**. Bids received in excess of the ABC shall be automatically rejected on bid opening.
2. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES now invites bids for the **SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF VIDEO SURVEILLANCE SYSTEM PROJECT FOR CAAP 16 AIRPORTS IN LUZON AND VISAYAS**. Delivery of the goods shall be in accordance with the delivery schedule under Section VI Schedule of Requirements. Bidders should have completed, within the **last five (5) years**, a single contract that is similar to this Project, equivalent to at least Fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. Interested bidders may obtain further information from the CIVIL AVIATION AUTHORITY OF THE PHILIPPINES and inspect the Bidding Documents at the address given below and during office hours.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **October 17, 2019 until the deadline of submission of bids** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 50,000.00**.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference on **November 14, 2019, 10:00 AM at the Civil Aviation Training Center (CATC), Merville Access Road, Pasay City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **December 12, 2019, 10:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **December 12, 2019, 10:00 AM at at the Civil Aviation Training Center (CATC), Merville Access Road, Pasay City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Civil Aviation Authority of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
