RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPAIR AND REPLACEMENT OF VARIOUS DOOR LOCKSET, DOOR CLOSER AND DOOR HINGES AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for **Repair and Replacement of Various Door Lockset, Door Closer and Door Hinges at Iloilo International Airport** in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of **Three Hundred Eighty Four Thousand Four Hundred Seventy Eight Pesos & 71/100. (P 384,478.71)**;

WHEREAS, in response to the said advertisement, one (1) interested bidder submitted their letter of intent;

WHEREAS, the detailed evaluation of bids conducted resulted in the following:

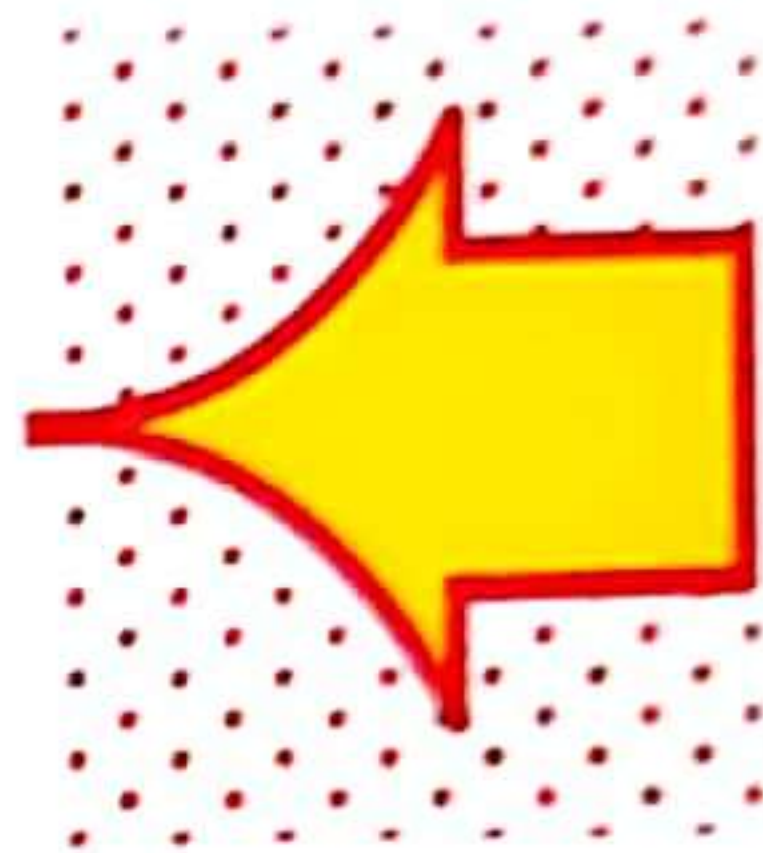

 - b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.


