



INVITATION TO BID FOR
Supply and Delivery of Block Up Converter (BUC) for VSAT at
Philippine ATMC.

21-005-12 ALPHA

1. The Civil Aviation Authority of the Philippines (CAAP), through the *CAAP Corporate Operating Budget for FY2021*, intends to apply the sum of Six Million Eight Hundred Forty Eight Thousand Pesos **Php 6,000,000.00** being the ABC to payments under the contract for ***Supply and Delivery of Block Up Converter (BUC) for VSAT at Philippine ATMC.*** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The CAAP now invites bids for the above Procurement Project. Delivery of the Goods is required ***within the contract duration of Ninety (90) calendar days.*** Bidders should have completed, within ***five (5) years*** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary ***“pass/fail”*** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from ***Civil Aviation Authority of the Philippines*** and inspect the Bidding Documents at the address given below during ***office hours from Monday to Friday at the BAC Office – Civil Aviation Authority of the Philippines (CAAP), MIA Road, Pasay City, 1300.***
5. A complete set of Bidding Documents may be acquired by interested Bidders on December 07, 2021 until the deadline of submission of bids from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***Php 10,000.00.*** The Procuring Entity shall allow the bidder to present its proof of payment for the fees ***in person or through electronic means.***

[NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB;

provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]

6. The **Civil Aviation Authority of the Philippines** will hold a Pre-Bid Conference¹ on December 14, 2021 @ 2:00PM at Civil Aviation Authority of the Philippines Conference Room and/or through video conferencing or webcasting via *Google Meet*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual or electronic submission at the office address indicated below on or before December 28, 2021 @ 2:00PM. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on December 28, 2021 @ 2:00PM at the given address below and/or via *online conference thru Google Meet*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Civil Aviation Authority of the Philippines** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
