RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF SUPPLIES OF GROUND MAINTENANCE OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2021-039-01 for the project **Supply and Delivery of Supplies of Ground Maintenance of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Eighty Five Thousand Nine Hundred Sixteen Pesos (₱ 85,916.00)** hereby form the integral part of this resolution. - a) To declare, **ILOILO IZEEM COMMERCIAL**, as the Supplier with the Single Calculated Responsive Quotation **Supply and Delivery of Supplies of Ground Maintenance of Iloilo International Airport** in the bid amount of **Eighty Four Thousand Seven Hundred Thirty Seven Pesos & 50/100 (₱ 84,737.50)**;
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.




