**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION  
AND RECOMMENDING APPROVAL FOR REPAIR AND MAINTENANCE OF  
ISUZU DMAX AT ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP 2021-022-05 for the project **Repair and Maintenance of Isuzu DMAX at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount **Eighty Three Thousand Nine Hundred Sixty Eight Pesos (₱ 83,968.00)** hereby form the integral part of this resolution.
