**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF
EMERGENCY LIGHT (WALL MOUNTED), MEASURING WHEEL AND DE-
HUMIDIFIER OF ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2021-035-02 for the project **Supply and Delivery of Emergency Light (Wall Mounted), Measuring Wheel and De-Humidifier of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Sixty Five Thousand Eight Hundred Ninety Five Pesos (₱ 65,895.00)** hereby form the integral part of this resolution. 
