



Invitation to Bid for

WIDENING OF RUNWAY INCLUDING GRADING OF BOTH RUNWAY END STRIPS AT PALANAN AIRPORT

Bid No. 19-014-03 ALPHA

1. The Civil Aviation Authority of the Philippines, through the Funds from DOTr Downloaded Projects intends to apply the sum of **NINETEEN MILLION FIVE HUNDRED FIFTY-EIGHT THOUSAND SIX HUNDRED SIXTY-FOUR PESOS 59/100 (PhP 19,558,664.59)** being the Approved Budget for the Contract (ABC) to payments under the contract for **WIDENING OF RUNWAY INCLUDING GRADING OF BOTH RUNWAY END STRIPS AT PALANAN AIRPORT (Bid No. 19-014-03 ALPHA)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Civil Aviation Authority of the Philippines now invites bids for **WIDENING OF RUNWAY INCLUDING GRADING OF BOTH RUNWAY END STRIPS AT PALANAN AIRPORT**.

Completion of the Works is required **One Hundred Fifty (150) Calendar Days (inclusive of eleven(11) rainy/unworkable days)**. Bidders should have completed a

contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila on **March 14, 2019 until deadline of submission of bid** and inspect the Bidding Documents at the address given below from 08:00 AM to 05:00 PM from MONDAY to FRIDAY.

5. A complete set of Bidding Documents may be acquired by interested bidders on **March 14, 2019 until deadline of submission of bid** from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php25,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference on **March 21, 2019 @ 2:00PM** at CAAP Conference Room, CAAP Compound, MIA Road Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **April 03, 2019 @ 2:00PM** at BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **April 03, 2019 @ 2:00PM** at CAAP Conference Room, CAAP Compound, MIA Road Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
