The **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP)** intends to apply the sum of **Twenty-Six Million Five Hundred Seventy-Two Thousand Seven Hundred Fifty Pesos & 20/100 (Php26,572,750.20)** for the **First One Year only**, being the **Approved Budget for the Contract (ABC)** to payment under the contract for **Provision of Security Services Requirements for CAAP AREA CENTER V under a Three (3)-Year Service Agreement (Re-Bid)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The CAAP through its Bids and Awards Committee – BRAVO (BAC-BRAVO) now invites bids for the said project (see details in the attached Terms of Reference).

3. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
4. Bidding shall be governed and conducted through open competitive bidding procedures using a non-discretionary “PASS/FAIL” criterion as specified in the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act” and such other requirements as indicated in the Bidding Documents.
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens

of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R. A. No. 5183.

6. Interested bidders may obtain further information from the BAC-BRAVO and inspect the Bidding Documents at the address given below during **Regular Office Hours from 8:00 A.M. to 5:00 P.M. (Monday to Friday)**.
7. A complete set of Bidding Documents may be acquired by interested bidders at the CAAP Office through the BAC-BRAVO Secretariat at the address given below upon payment of a non-refundable participation fee for the Bidding Documents.
8. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the CAAP, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
9. The BAC-BRAVO will hold a **Pre-Bid Conference on June 20, 2019, 1:00 P.M.** at the **Civil Aviation Training Center (CATC), Merville Access Road, Pasay City**, which shall be open to all prospective bidders.
10. Bids must be duly received by the BAC-BRAVO Secretariat at the **Civil Aviation Training Center (CATC), Merville Access Road, Pasay City** on or before **10:00 A.M. of July 11, 2019**. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.
11. **Bids opening** shall be on **July 11, 2019 at 1:00 P.M.** at the **Civil Aviation Training Center (CATC), Merville Access Road, Pasay City**. Bids will be opened in the presence of the bidder's representatives who choose to attend. Late bids shall not be accepted.
12. The CAAP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of R. A. No. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
