Sealed Bids shall be submitted to The Secretariat Disposal Committee, (Attention: Mr. Ernest L. Novis), Supply Division, CAAP Central Office, MIA Road Pasay City not later than 10:00 A.M. on February 17, 2020, after which, opening of Bids shall be conducted at 10:30 A.M., same day February 17, 2020 at the DDG-A Conference Room, in the presence of the Bidders or their duly authorized representative.

A bid bond shall be imposed on each bidder in the amount equal to Ten Percent (10%) of the floor price which will be refunded after completion of the bidding process. Bidders can purchase bid documents at Three Hundred Pesos (Php 300.00) at Supply Division to be paid at CAAP cashing unit. It is agreed that the winning bidder should complete/finish withdrawal of all the items within 15 working days from the date of full payment of his bid. Failure to withdraw the items within the stipulated period shall have the effect of cancellation of the Award.

The CAAP reserves the right to reject any or all bids thereof, waive defects or formality requirements contained therein or to accept bid that is considered responsive and most advantageous to the Government.
