



Invitation to Bid for ***Supply, Installation and Testing of Aerodrome Tower*** ***Simulators***

Bid No: 19-003-02

1. The Civil Aviation Authority of the Philippines (CAAP), through the Corporate Budget of 2019, intends to apply the sum of "One Hundred Million Pesos (100,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for "Supply, Installation, and Testing of Aerodrome Tower Simulators". Bids received in excess of the ABC shall automatically be rejected during bid opening.
2. The CAAP through the Bids and Awards Committee now invites bids for the Supply, Installation and Testing of Aerodrome Tower Simulators. Bidders should have completed, within ten (10) years from the date submission and receipt of bids, two (2) contracts similar to the Project. The Simulator System will be installed at the Civil Aviation Training Center (CATC) and two (2) Self Trainer Tower Simulators to Manila Tower. The delivery of the Goods must be completed within one hundred (100) calendar days from receipt of Notice to Proceed (NTP). The description of an eligible bidder is contained in the Bidding Documents, particularly Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the revised IRR of R.A. 9184.

4. Interested Bidders may obtain further information from the CAAP BAC Secretariat and inspect the Bidding Documents at BAC Secretariat, Civil Aviation Authority of the Philippines, MIA Road, Pasay City during office hours from 8:00 AM to 5:00 PM.

The Bidding Documents may be obtained for a non-refundable fee of FIFTY THOUSAND PESOS (PHP50,000.00) by interested bidders on February 11, 2019.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of CAAP for reference, provided that Bidders shall pay the non-refundable fee not later than the published time and date of submission of their bids.

5. The CAAP will hold the Pre-bid conference on February 14, 2019 @ 2:00 PM at the Civil Aviation Training Center (CATC), Merville Access Rd, 201, Pasay, 1300 Metro Manila, which shall be open to all interested parties. However, a maximum of three (3) representatives for each bidder will only be allowed due to space limitation.
6. Bids must be delivered to BAC Secretariat on or before 2:00 PM of February 26, 2019. Late submission will not be accepted.

Bid opening shall be on February 26, 2019 @ 2:00 PM at the Civil Aviation Training Center (CATC). Bids will be opened in the presence of Bidders' representatives who chose to attend.

7. CAAP reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
