



**REQUEST FOR EXPRESSION OF INTEREST FOR
CONSULTANCY SERVICES FOR CONSTRUCTION OF ATS
BUILDING PROJECT
Bid No. 19-018-04 Bravo**

1. The Civil Aviation Authority of the Philippines, (CAAP) through its FY 2019 Annual procurement plan (APP) intends to apply the sum of **Four Million Eight Hundred Sixteen Thousand Three Hundred Thirty-Eight Pesos (Php 4,816,338.00)**, being the Approved Budget for the Contract (ABC) to payments under the contract for **Consultancy Services for Construction of ATS Building Project (Bid No. 19-018-04)**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The CAAP now calls for the submission of eligibility documents for **Consultancy Services for Construction of ATS Building Project**. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **10:00 A.M., 23 May 2019** at Civil Aviation Training Center (CATC), Merville Access Road, Pasay City. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. Interested bidders may obtain further information from BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila on **24 April 2019 until the deadline of submission of bid** and inspect the Bidding Documents at the address given below during 08:00 AM to 05:00 PM from MONDAY to FRIDAY.
4. A complete set of Bidding Documents may be acquired by interested bidders on **24 April 2019 until the deadline of submission of bid** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **(Php 5,000.00)**.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The CAAP will hold a Pre-eligibility Conference on **10:00 A.M., 08 May 2019** at Civil Aviation Training Center (CATC), Merville Access Road, Pasay City
6. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR).


The short list shall consist of five (5) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

- a. Applicable experience of the consultant and associates in case of joint ventures – 40%;
 - b. Qualification of principal and key staff of the consultant who may be assigned to the job vis-à-vis extent and complexity of the undertaking – 50%;
 - c. Current workload relative to capacity – 10%
7. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.
- Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
8. The CAAP shall evaluate bids using the Quality Based Evaluation (QBE). The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
9. The contract shall be completed within **Ninety (90) Calendar Days**.
10. The CAAP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
