



Invitation to Bid for

CONSTRUCTION OF CSIS OFFICE AT ROMBLON AIRPORT Bid No. PL-POI-03-2019

1. The Civil Aviation Authority of the Philippines, through the CAAP Corporate Budget CY 2019 intends to apply the sum of **ONE MILLION SIX HUNDRED FIFTY THOUSAND PESOS (PhP 1,650,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **CONSTRUCTION OF CSIS OFFICE AT ROMBLON AIRPORT Bid No. PL-POI-03-2019**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Civil Aviation Authority of the Philippines now invites bids for **CONSTRUCTION OF CSIS OFFICE AT ROMBLON AIRPORT**.

Completion of the Works is required **Completion of the Works is required for Ninety Calendar Days (90 days inclusive of rainy/unworkable days)**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Civil Aviation Authority of the Philippines, Plaridel Bulacan and inspect the Bidding Documents at the address given below from 8am – 5pm MONDAY to FRIDAY.
5. A complete set of Bidding Documents may be acquired by interested bidders on July 18, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 2,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference¹ on July 24, 2019, 2:00pm at Plaridel Airport Lumang Bayan, Plaridel Bulacan, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *August 7, 2019, 10:00am*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **ITB** Clause.

Bid opening shall be on August 7, 2019, 2:00pm at Plaridel Airport Lumang Bayan, Plaridel Bulacan. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Civil Aviation Authority of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
