- Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security – **Thirty Percent (30%) of the Total Contract Price**


The performance security shall be posted in favor of **CAAP – AC XI** and shall contain the conditions prescribed by R.A. 9184 and its implementing rules and regulations, as amended.

Furthermore, you are also required to submit the following as indicated in the *Bid Data Sheet* and *Special Conditions of Contract in the Public Bidding Documents* in two copies within the same ten (10) calendar days:


