A RESOLUTION DECLARING TRUE-TEMP CORPORATION THE SINGLE CALCULATED RESPONSIVE BIDDER (SCRB) AND RECOMMENDING TO AWARD THE PROJECT: "SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF SECONDARY CHILLED WATER PUMP WITH VFD"

WHEREAS, the Civil Aviation Authority of the Philippines – Area XI posted in PhilGEPS and advertised continuously in three (3) conspicuous places for seven (7) calendar days the Invitation to Bid of **SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF SECONDARY CHILLED WATER PUMP WITH VFD**;

WHEREAS, as indicated in the advertisement, the pre-bidding was held on **May 31, 2019** at **CAAP-Admin Building, Davao International Airport** which was followed by the opening of bids on **June 14, 2019** at **CAAP-Admin Building, Davao International Airport**;

WHEREAS, on the day of the opening of bids for the said project, **two bidders** namely **TRUE-TEMP CORPORATION AND FLOW HARMONIC COMMERCIAL, INC.** submitted their bid documents on or before the deadline of submission/dropping of bids.

WHEREAS, upon initial evaluation for the eligibility of the bids, **only** the bid of **TRUE-TEMP CORPORATION** was found eligible and passed the checking of technical and financial documents;

WHEREAS, the bid of the eligible bidder underwent the process of Detailed Bid Evaluation for the period **June 14-21, 2019**;

WHEREAS, the Bid Evaluation Report showed that the bid of **TRUE-TEMP CORPORATION** was found to be complete and complying and was declared as the **Single Calculated Bid (SCB)** with a bid price of **One Million Eight Hundred Thousand Pesos Only (P 1,800,000.00)** through **BAC Resolution No. 2019-06-022**;

WHEREAS, Section 34.1 of the 2016 Revised IRR of RA 9184 states that, *"The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification in order to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents."*;

WHEREAS, upon the declaration of the SCB, the bid of **TRUE-TEMP CORPORATION** was post-qualified;


WHEREAS, the TWG submitted their Post-qualification Report on **July 2, 2019** with a finding that **TRUE-TEMP CORPORATION** is a **Single Calculated Responsive Bidder** and was recommended to be awarded through BAC Resolution signed by the BAC and approved by the Head of the Procuring Entity;


WHEREAS, the BAC confirms the findings and conclusion of the TWG;


NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED, to declare TRUE-TEMP CORPORATION as the Single Calculated Responsive Bidder (SCRB) with its bid amounting to One Million Eight Hundred Thousand Pesos Only (P 1,800,000.00) and is hereby recommended for Award of Contract for the project "SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF SECONDARY CHILLED WATER PUMP WITH VFD".


