



## **INVITATION TO BID**

### **SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF AUDIO VISUAL EQUIPMENT FOR CAAP BOARD ROOM AND CONFERENCE ROOM Bid No. 19-047-08 BRAVO**

1. The **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP)**, through the CAAP Corporate Budget CY 2019 intends to apply the sum of **THREE MILLION FIVE HUNDRED THOUSAND PESOS (Php3,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF AUDIO VISUAL EQUIPMENT FOR CAAP BOARD ROOM AND CONFERENCE ROOM**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The CAAP now invites bids for the **SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF AUDIO VISUAL EQUIPMENT FOR CAAP BOARD ROOM AND CONFERENCE ROOM**.

Delivery of the Goods is required within One Hundred Twenty (120) calendar days. Bidders should have completed within one (1) year from the date of submission and receipt of bids, an aggregate contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from the Civil Aviation Authority of the Philippines and inspect the Bidding Documents at the address given below during office hours.

A complete set of Bidding Documents may be purchased by interested Bidders on **23 August 2019** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **FIVE THOUSAND PESOS (PhP 5,000.00)** only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) <http://www.philgeps.net> and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.


5. The CAAP will hold a **Pre-Bid Conference** on **05 SEPTEMBER 2019, 10:00 AM** at the **Civil Aviation Training Center (CATC), Merville Access Road, Pasay City** which shall be open to all interested parties.

6. Bids must be duly received by the BAC Secretariat at the Civil Aviation Training Center (CATC), Merville Access Road, Pasay City on or before **19 SEPTEMBER 2019, 10:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

**Bid opening** shall be on **19 SEPTEMBER 2019**, Civil Aviation Training Center (CATC), Merville Access Road, Pasay City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The CAAP reserves the right to accept or reject any and all bids, declare a failure of bidding, or to annul the bidding process, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
