**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF OFFICE SUPPLIES FOR FEBRUARY TO APRIL 2021 AT ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP 2021-004-01 for the project **Supply and Delivery of Office Supplies for February to April 2021 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Twenty One Thousand Nine Hundred Fifty Four Pesos (P221,954.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

**WHEREAS**, (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

**WHEREAS**, four (4) interested suppliers submitted their sealed quotations;

**WHEREAS**, during the opening of quotations, **NEWTON MERCHANDISING, INC.** violated the Terms and Conditions No. 6 "*Quotation exceeding the Approved Budget for the Contract shall be rejected.*" as stated in the Request for Quotation;

**WHEREAS**, the price quotation of the bidder were found to be substantially compliant:

**NOW THEREFORE**, We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:


- a) To disqualify, **NEWTON MERCHANDISING, INC.** for quoting above the Approved Budget for the Contract;







