



**Invitation to Bid for**

**STRIP GRADE CORRECTION AT KALIBO  
INTERNATIONAL AIRPORT  
Bid No. 19-037-09 ALPHA**

1. The Civil Aviation Authority of the Philippines, through the CAAP Corporate Budget CY 2019 intends to apply the sum of **THIRTY-EIGHT MILLION SEVEN HUNDRED SIXTY-ONE THOUSAND EIGHT HUNDRED THIRTEEN PESOS & 44/100 (Php 38,761,813.44)** being the Approved Budget for the Contract (ABC) to payments under the contract for **STRIP GRADE CORRECTION AT KALIBO INTERNATIONAL AIRPORT (Bid No. 19-037-09 ALPHA)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
  
2. The Civil Aviation Authority of the Philippines now invites bids for **STRIP GRADE CORRECTION AT KALIBO INTERNATIONAL AIRPORT**.

Completion of the Works is required **One Hundred Sixty-Five (165) Calendar Days (inclusive of twenty-three (23) rainy/unworkable days)**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila on **Sept 23, 2019 until deadline of submission of bid** and inspect the Bidding Documents at the address given below from 08:00 AM to 05:00 PM from MONDAY to FRIDAY.
5. A complete set of Bidding Documents may be acquired by interested bidders on **Sept 23, 2019 until deadline of submission of bid** from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php25,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Interested bidders shall submit the following documents to the ADMS Office upon acquiring the Bidding Documents:

- a. Copy of valid PCAB License & Registration
- b. Company I.D.
- c. Authorization letter from Company


6. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference on **Oct. 01, 2019 @ 2:00PM** at CAAP Conference Room, CAAP Compound, MIA Road Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **Oct. 15, 2019 @ 2:00PM** at BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **Oct 15, 2019 @ 2:00PM** at CAAP Conference Room, CAAP Compound, MIA Road Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Civil Aviation Authority of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
