**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND
RECOMMENDING APPROVAL FOR THE REPAIR AND MAINTENANCE OF 3
UNITS PASSENGER BOARDING BRIDGES AT ILOILO INTERNATIONAL
AIRPORT**

- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.


