- Bid must be complete and award will be made on a lump sum basis.
- 4. Price validity shall be for a period of One Hundred Twenty (120) calendar days.
- 5. The following should be submitted together with the quotation:
 - 5.1 Valid PCAB License Small A;
 - 5.2 Current Mayor's/Business Permit;
 - 5.3 Phil-GEPS Registration Number;
 - 5.4 Name/credentials of proposed Construction Foreman, and Safety Officer; and
 - 5.5 List of Contractor's Equipment (welding machine, and bar cutter);

 The contractor's major equipment units, which are owned, leased, and/or under purchase agreements must be supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, which must meet the minimum requirements.

Quotations not accompanied by current Mayor's/Business Permit; valid PCAB License Small A; name/credentials of proposed Construction Foreman and Safety Officer; List of Contractor's Equipment with corresponding proof of ownership/certification of availability; and Phil-GEPS Registration Number shall be automatically disqualified.

Prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded.
