RECOMMENDATION TO AWARD THE CONTRACT: “REPAIR AND MAINTENANCE OF OSHKOSH STRIKER (NEW)” TO ASIAN AEROSPACE CORPORATION PROCURED VIA DIRECT CONTRACTING

WHEREAS, the approved 2021 Annual Procurement Plan (APP) of the Civil Aviation Authority of the Philippines Area XI one of the items approved therein with Public Bidding as its original mode of procurement was the project, **“REPAIR AND MAINTENANCE OF OSHKOSH STRIKER (NEW)”**

WHEREAS, the change in the mode of procurement from Public Bidding to Direct Contracting was recommended by the Bids and Awards Committee and approved by the Head of Procuring Entity through **BAC Resolution 2021-05-11 dated May 7, 2021** ;

WHEREAS, the BAC through its BAC Secretariat posted for information purposes, the Notice to Conduct Direct Contracting with the Request for Quotation of the contract, **“REPAIR AND MAINTENANCE OF OSHKOSH STRIKER (NEW)”** in its official website and in three (3) conspicuous places within its premises for seven (7) calendar days;

WHEREAS, as indicated in the notice, Asian Aerospace Corporation, the sole and only distributor for the project was required to submit their quotation and requirements from June 9, 2021 until June 16, 2021;

WHEREAS, a deliberation of the submitted requirements was held on June 16, 2021. Below are the results of the deliberation:

WHEREAS, the BAC decided to notify Asian Aerospace of the results and to submit the lacking requirements on June 18, 2021 which they immediately complied.


WHEREAS, the second deliberation for the submitted requirements was held on June 23, 2021 at CAAP-General Santos City where **Asian Aerospace Corporation was found to be complete and complying** with the requirements for the Direct Contracting of this project with an




approved quoted price of **ONE MILLION EIGHTY-ONE THOUSAND TWO HUNDRED EIGHTY-ONE PESOS ONLY (1,081,281.00)**;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby **RESOLVED**, to declare **ASIAN AEROSPACE CORPORATION** as the **Direct Contractor** with the approved quoted price of **ONE MILLION EIGHTY-ONE THOUSAND TWO HUNDRED EIGHTY-ONE PESOS ONLY (1,081,281.00)** and is hereby recommended for Award of Contract of **"REPAIR AND MAINTENANCE OF OSHKOSH STRIKER (NEW)"**.
