1. The **Civil Aviation Authority of the Philippines Iloilo International Airport** intends to procure **Repair of U-Ditch Canal at Airside Area at Iloilo International Airport** with the Approved Budget for the Contract (ABC) of **Three Hundred Thirty Seven Thousand Two Hundred Six Pesos & 72/100 (P337,206.72)**.
2. The **CAAP Iloilo International Airport**, through its Bids and Award Committee (BAC), now invites technically, legally, and financially capable suppliers for the said **Repair of U-Ditch Canal at Airside Area at Iloilo International Airport**.
3. The procurement procedure for this requirement is Negotiated Procurement pursuant to Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of the Republic Act (R.A.) No. 9184, otherwise known as the “Government Procurement Reform Act”, including Annex H thereof.


