**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND
RECOMMENDING APPROVAL FOR THE REPAIR AND MAINTENANCE OF FIRE
DETECTION AND ALARM SYSTEM AND FIRE PROTECTION SYSTEM AT ILOILO
INTERNATIONAL AIRPORT**

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for **Repair and Maintenance of Fire Detection and Alarm System and Fire Protection System at Iloilo International Airport** in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of **Eight Hundred Fourteen Thousand Nine Hundred Seventy One Pesos (₱ 814,971.00)**;

WHEREAS, in response to the said advertisement, two (2) interested bidders submitted their letter of intent and bought the bidding documents;

WHEREAS, on the day of the Preliminary Examination of Bids, two (2) bidders submitted their sealed bid proposals;

WHEREAS, **BAC FIRE INDUSTRIAL SUPPLIES**, is fail to attach their Audited Financial Statement. in Accordance with Section 23.1(a) (iv) of the revised Implementing Rules and Regulation (IRR) of Republic Act (RA) No. 9184 *"The Submission of the eligibility documents enumerated in Section 23.1 of the IRR 9184 is a mandatory requirement that must be complied with by the prospective bidders, such that failure to submit any of the documents or submission of an otherwise incomplete or patently insufficient document, will disqualify the bidder based on the non-discretionary "pass/fail" criterion under Section 30.1 of the IRR of RA 9184"*;

WHEREAS, the price quotations of the bidder was found to be substantially complying:

- b) To declare **ALTO AUDIO DESIGN CENTER** as the Supplier with the Single Calculated Responsive Bid for the **Repair and Maintenance of Fire Detection and Alarm System and Fire Protection System at Iloilo International Airport** in the bid amount of **Seven Hundred Ninety Thousand Pesos (₱ 790,000.00)**;
- c) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
