

CONTRACT AGREEMENT

Repair And Repainting Of ARFF Building At Daet Airport – 2nd SVP

THIS AGREEMENT made this **JUN 08 2021** day of _____ 2021 between **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES** with office address at Legazpi Airport, Legazpi City [hereinafter called “the Entity”] and **LJDB CONSTRUCTION** of Teofilo St., Purok 2, Centro Oriental, Polangui, Albay [hereinafter called “the Contractor”].

WHEREAS, the Entity is desirous that the Contractor execute the **Repair And Repainting Of ARFF Building At Daet Airport – 2nd SVP** (hereinafter called “the Works”) and the Entity has accepted the Bid for **Six Hundred Twenty Two Thousand Four Hundred Fifty Three Pesos & 14/100 (Php 622,453.14)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

WHEREAS, the start date of the contract shall be the date of receipt of the Notice to Proceed (NTP) and completion of the Works is required within **Fifty eight (58) calendar days including ten (10) days unfavorable weather condition;**

WHEREAS, in case the contractor refuses or fails to satisfactorily complete the work within the specified contract time, plus any time extension duly granted and is hereby in default under the contract, the contractor shall pay the procuring entity for liquidated damages, and not by way of penalty, an amount, as provided in the conditions of contract, equal to at least one tenth (1/10) of one (1) percent of the cost of the unperformed portion of the works for every day of delay, and once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, CAAP may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Invitation For Price Quotation and Request For Price Quotation;
 - i. Drawings/Plans, if any;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. Supplemental or Bid Bulletins, if any;
 - (b) Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted. Bid form (bid proposal) including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - (c) Performance Security;
 - (d) Notice of Award of Contract and the Bidder’s conforme thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Six Hundred Twenty Two Thousand Four Hundred Fifty Three Pesos & 14/100 (Php 622,453.14)**, **LJDB CONSTRUCTION** agrees to execute and complete the Works, **i.e., the repair and repainting of the ARFF Building at Daet Airport**, and remedy any defects therein in accordance with its Bid.


4. The **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.
5. Execution of "the Works" should not cause considerable inconvenience to the flying public nor should it in any way disrupt airport/aircraft operations hence, it should be done upon clearance from proper airport authorities, and all necessary safety precautions must be implemented.


