**SUBJECT : VALIDITY OF THE EXTENDED CAAP ISSUED AIR OPERATOR CERTIFICATE, VALIDATION OF FOREIGN AIR OPERATOR CERTIFICATE, DANGEROUS GOODS CERTIFICATE, RPAS OPERATOR CERTIFICATE, AGRICULTURAL AIRCRAFT OPERATOR CERTIFICATE, CERTIFICATE OF AUTHORIZATION, SIMULATOR ACCREDITATION CERTIFICATE, SIMULATOR QUALIFICATION CERTIFICATE AND CABIN CREW COMPETENCY CERTIFICATION**

**DATE : 29 MARCH 2021**

The Flight Standards Inspectorate Service has progressively resumed to new normal operations. Though operating in a limited capacity, the Flight Operations Department is now accepting applications for Air Operator Certificate, Validation of Foreign Air Operator Certificate, Dangerous Goods Certificate, RPAS Operator Certificate, Agricultural Aircraft Operator Certificate, Certificate of Authorization, Simulator Accreditation Certificate, Simulator Qualification Certificate and Cabin Crew Competency Certification, for prioritization and sequential processing.

In view of this, please be informed that all certificates emanating from the Flight Operations Department, which were extended pursuant to Memorandum Circular No. 10-2020 dated 13 March 2020 and Memorandum Circular No. 14-2020 dated 16 March 2020 will only remain valid until **30 SEPTEMBER 2021**.


Stakeholders are encouraged to submit timely their respective application for certification to avoid untoward disruption of operations.

In the interim, application will be evaluated and processed through desk audit only and without the mandatory on-site inspection. However, certificates issued under the desk audit procedure will be subsequently scheduled for an on-site audit when travel of inspectors and auditors is permissible.
