Ladies and Gentlemen:

This refers to the **Public Bidding** for the contract "**REPAIR AND UPGRADING OF DOMESTIC AND INTERNATIONAL BHS CONTROL PANEL**" conducted by the **Civil Aviation Authority of the Philippines - Area XI**, the Procuring Entity.

We are pleased to inform you that the above-stated contract is hereby awarded in favor of **ALJON INTERNATIONAL CORPORATION** being the bidder with the **Single Calculated Responsive Bid (SCRB)** in the amount of **FOUR MILLION TWO HUNDRED NINETEEN THOUSAND ONE HUNDRED THIRTY-ONE PESOS ONLY (4,219,131.00)**.

You are hereby required to formally enter into contract with the herein Procuring Entity **strictly within ten (10) calendar days** from receipt of this notice and submit **any one (1)** of the following documents within the same 10 CD period for this purpose:

- a. Cash or cashier's/manager's check issued by a Universal or Commercial Bank - **Five Percent (5%) of the Total Contract Price**
- b. Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank - **Five percent (5%) of the Total Price**
- c. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security - **Thirty Percent (30%) of the Total Contract Price**

The performance security shall be posted in favor of the Procuring Entity and shall contain the conditions prescribed by R.A. 9184 and its implementing rules and regulations, as amended. Failure to enter into the said contract or provide the required Performance Security shall disqualify the bid of **ALJON INTERNATIONAL CORPORATION** and render this notice canceled.


In addition to above-mentioned requirement, the SCRB shall also submit the following before the start of the work period:

1. Occupational Safety and Health Program approved by Region XI DOLE;
2. Gantt Chart showing the schedule of work activities within the period;
3. Manpower Schedule; and
4. Tarpaulin indicating the contract information (as indicated in the Terms of Reference. Format from the agency)
