Sealed Bids shall be submitted to the Secretariat Waste Disposal Committee, (Attention: Ms. Imelda A. Gasatan), of CAAP Laoag International Airport, not later than 3:00 PM, April 25, 2022, after which, opening of Bids shall be conducted at 3:00PM, same day April 25, 2022 at the New Administration Building Conference Room in the presence (virtual/face-to-face) of the Bidder/s or their duly authorized representative/s.

The bidder shall enclose in the sealed envelope the following:

- a. Fully –accomplished Bid Form;
- b. Minimum bond; and
- c. Photo copy of latest Mayor's business permit;
- d. Authorization of the bidder for his/her representative/s

A bid bond shall be imposed on each bidder in the amount equal to **10%** of the floor price (**Php. 2,000.00**) per lot which will be refunded after completion of the bidding process. Bidders can purchase bid documents at **Php. 200.00** at the Collecting Unit. It is agreed that the winning bidder should complete/finish withdrawal of all the items within **15 working days** from the date of full payment of his bid. Failure to withdraw the items within the stipulated period shall have the effect of cancellation of the award.

The CAAP reserves the right to reject any or all bids thereof, waive defects or formality requirements contained therein or to accept bid that is considered responsive and most advantageous to the Government.
