It is requested that price quotations be submitted in an envelope, duly sealed, to be opened by our Bids and Awards Committee on **31 May 2022 at 2:00 pm** at the BAC Office, Ground Floor, Admin Bldg, Bicol International Airport (BIA), Daraga, Albay.

SCOPE OF WORK/SERVICES:

1. Regular garbage collection at five o'clock in the morning (5:00 AM) or six o'clock in the evening (6:00 PM), every 10th, 20th and 30th day of each month at the BIA premises pick-up area.
2. On-site segregation of bio-degradable, non-biodegradable and hazardous wastes.
3. Complete transporting of all collected wastes to the DENR-EMB authorized Sanitary LandFill.
4. Deployment of appropriate waste collection vehicles (DENR-EMB) accredited/registered with 3-5 tons load capacity for the scheduled collection.
5. Transporter to provide a complete transporting plan for the whole duration of the contract.
6. Submit accomplishment report for collection activity supported with photo-documentation.
7. Submit monthly billing statement on the day after the last day of the month serviced.

Quotations not accompanied by Current Mayor's/Business Permit, Phil-GEPS Registration Number, Proof of accreditation/registration issued by DENR-EMB to the garbage collection and disposal business, Proof that the business has been operating for at least one (1) year, Proof that the garbage collection and disposal business has been operating for at least three (3) years, Proof of accreditation/registration of collection vehicle/s with 3-5 tons load capacity issued by DENR-EMB; and List of Contractor's Equipment (collection vehicle/s with 3-5 tons load capacity) with corresponding proof of ownership/certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, which must meet the minimum requirements shall be automatically disqualified.

Your prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded. Quotations must be delivered to the Civil Aviation Authority of the Philippines, Area Center V **not later than 2:00 p.m. on 31 May 2022** at its physical address at the BAC Office, Ground Floor Admin Bldg., Bicol International Airport, Daraga, Albay. **Online submission is not allowed and late submission shall not be accepted.**


Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late quotations shall not be accepted. All quotations together with the required documents should be placed in a **sealed envelope marked Garbage Collection And Disposal Services Of Solid Wastes For Bicol International Airport – 4th SVP.**

A **Service Contract** for the Garbage Collection And Disposal (**Annex "A"**) shall be drawn between CAAP and the winning bidder.

The Approved Budget for the Contract (ABC) is **Six Hundred Thousand Pesos (Php 600,000.00).**

Contract Duration: **Garbage collection and Disposal Services shall be done Three (3) times a month for a period of one (1) year.**
