This refers to the **Public Bidding** for the contract "REHABILITATION OF EXISTING SECURITY FENCE (3M/BAY) ALONG KJC AREA" conducted by the **Civil Aviation Authority of the Philippines - Area XI**, the Procuring Entity.

You are hereby required to formally enter into contract with the herein Procuring Entity **within ten (10) calendar days** from receipt of this notice and submit **any one (1)** of the following documents for this purpose:

- a. Cash or cashier's/manager's check issued by a Universal or Commercial Bank – **Ten Percent (10%) of the Total Contract Price**
- b. Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank – **Ten percent (10%) of the Total Price**
- c. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security – **Thirty Percent (30%) of the Total Contract Price**

The performance security shall be posted in favor of the Procuring Entity and shall contain the conditions prescribed by R.A. 9184 and its implementing rules and regulations, as amended. Failure to enter into the said contract or provide the required Performance Security shall disqualify the bid of **R. FABALE CONSTRUCTION CORP.** and render this notice canceled.

In addition to above-mentioned requirement, the LCRB shall also submit the **Construction Safety and Health Program approved by Region XI DOLE upon contract signing** and the following before the start of the work period:

1. Gantt Chart showing the schedule of work activities within the period;
2. Manpower Schedule; and
