**DECLARATION OF ERGO CONTRACTS PHILS., INC. AS THE LOWEST CALCULATED RESPONSIVE BIDDER (LCRB) AND RECOMMENDATION TO AWARD THE CONTRACT:  
 "SUPPLY, DELIVERY AND ASSEMBLY OF 300 UNITS 4-SEATER GANG CHAIRS AND VIP ROOM FURNITURES AT GENERAL SANTOS AIRPORT"**

**WHEREAS**, the Civil Aviation Authority of the Philippines – Area XI posted in PhilGEPS and advertised continuously in three (3) conspicuous places for seven (7) calendar days, the Invitation to Bid of **"SUPPLY, DELIVERY AND ASSEMBLY OF 300 UNITS 4-SEATER GANG CHAIRS AND VIP ROOM FURNITURES AT GENERAL SANTOS AIRPORT"**;

**WHEREAS**, as indicated in the advertisement, the pre-bidding was held on **May 5, 2022** at **CAAP-General Santos City** which was followed by the opening of bids on **May 17, 2022** at **CAAP- General Santos City**;

**WHEREAS**, on the day of the opening of bids for the said project, **six (6) bidders** namely, **(1) WEBCODE I.T. SOLUTIONS, (2) PENITON TRADING, (3) ALJON INTERNATIONAL CORP., (4) PROGRESS HOME & OFFICE FURNISHINGS, (5) ERGO CONTRACTS PHILS., INC., and (6) LBPI DESIGN INTERNATIONAL INC.** submitted their bid documents on or before the deadline of submission/dropping of bids.

**WHEREAS**, the result of the initial evaluation for the eligibility of the bids is shown in the table below:

**WHEREAS**, the bid of the eligible bidder(s) underwent the process of Detailed Bid Evaluation held on **May 18, 2022** at **CAAP- General Santos City Airport**;

**WHEREAS**, the Bid Evaluation Report showed that the bid of **ERGO CONTRACTS PHILS., INC.** was found to be complete and compliant and was declared as the **Lowest Calculated Bid (LCB)** with a bid price of **FIVE MILLION THREE HUNDRED SEVENTY-ONE THOUSAND NINE HUNDRED TWENTY PESOS AND THIRTY-SEVEN CENTAVOS ONLY (₱ 5,371,920.37)** through **BAC Resolution No. 2022-05-05** dated **May 18, 2022**;

**WHEREAS**, Section 34.1 of the 2016 Revised IRR of RA 9184 states that, *"The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification in order to determine whether the bidder concerned*



complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents.”;

**WHEREAS**, upon the declaration of the LCB, the bid of **ERGO CONTRACTS PHILS., INC.** was post-qualified within **6 CD from May 19-24, 2022**;


**WHEREAS**, the Post-qualification was completed on **May 24, 2022** validated with a Post-qualification Report with a finding that **ERGO CONTRACTS PHILS., INC.** is the **Lowest Calculated Responsive Bidder** and was recommended for award through BAC Resolution signed by the BAC and approved by the Head of the Procuring Entity;

**WHEREAS**, the BAC confirms the findings and recommendation of the BAC/TWG who conducted the Post-qualification;


**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby **RESOLVED**, to declare **ERGO CONTRACTS PHILS., INC** as the **Lowest Calculated Responsive Bidder (LCRB)** with a bid amounting to **FIVE MILLION THREE HUNDRED SEVENTY-ONE THOUSAND NINE HUNDRED TWENTY PESOS AND THIRTY-SEVEN CENTAVOS ONLY (₱ 5,371,920.37)** and is hereby recommended for Award of Contract of **“SUPPLY, DELIVERY AND ASSEMBLY OF 300 UNITS 4-SEATER GANG CHAIRS AND VIP ROOM FURNITURES AT GENERAL SANTOS AIRPORT”**.


