WHEREAS, BAC Resolution No. BDC 2022-002-02 for the project **PURCHASE OF TONER FOR PTBs PHOTOCOPIER & SPAREPARTS OF HRs PHOTOCOPIER AT ILOILO INTERNATIONAL AIRPORT** with Approved Budget for the Contract (ABC) in the amount of **FOURTEEN THOUSAND FOUR HUNDRED SIXTY PESOS ONLY (P14,460.00)** hereby forms the integral part of this resolution. 
