RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING FOR THE APPROVAL OF SUPPLY AND DELIVERY OF VEHICLE STICKERS FOR FY 2023 OF ILOILO INTERNATIONAL AIRPORT
