**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR REPLACEMENT OF SPARE PARTS OF PTB PHOTOCOPIER (SHARP AR-5320) AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BDC 2023-003-01 for the project **Replacement of Spare Parts of PTB Photocopier (Sharp AR-5320) at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Nine Thousand Seven Hundred Eighty Five Pesos (P 9,785.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (1) Request for Quotations (RFQ) was forwarded to exclusive supplier;

WHEREAS, Acknowledgement Receipt is attached as proof that copy of Request for Quotation (RFQ) was distributed;

WHEREAS, exclusive supplier submitted their quotation;

WHEREAS, during the Bid Opening last April 17, 2023, **COMPUTRON BUSINESS CENTER**, was declared Single Calculated Bid with the Bid amount of **Nine Thousand Seven Hundred Eighty Five Pesos (P 9,785.00)** and was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.


