RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR REPLACEMENT OF SPARE PARTS OF PTB PHOTOCOPIER (SHARP AR-5320) AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BDC 2023-004-03 for the project Supply and Delivery of Toners for HR and PTB Photocopier of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Sixteen Thousand Seven Hundred Twenty Five Pesos (P 16,725.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (1) Request for Quotations (RFQ) was forwarded to exclusive supplier;

WHEREAS, Acknowledgement Receipt is attached as proof that copy of Request for Quotation (RFQ) was distributed;

WHEREAS, exclusive supplier submitted their quotation;

WHEREAS, during the Bid Opening last June 13, 2023, COMPUTRON BUSINESS CENTER, was declared Single Calculated Bid with the Bid amount of Sixteen Thousand Seven Hundred Twenty Five Pesos (₱ 16,725.00) and was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
