**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND  
RECOMMENDING APPROVAL FOR REPLACEMENT OF SPARE PARTS OF PTB  
PHOTOCOPIER (SHARP AR-5320) AT ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, BAC Resolution No. BDC 2023-004-03 for the project **Supply and Delivery of Toners for HR and PTB Photocopier of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Sixteen Thousand Seven Hundred Twenty Five Pesos (P 16,725.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

**WHEREAS**, (1) Request for Quotations (RFQ) was forwarded to exclusive supplier;

**WHEREAS**, Acknowledgement Receipt is attached as proof that copy of Request for Quotation (RFQ) was distributed;

**WHEREAS**, exclusive supplier submitted their quotation;

**WHEREAS**, during the Bid Opening last June 13, 2023, **COMPUTRON BUSINESS CENTER**, was declared Single Calculated Bid with the Bid amount of Sixteen Thousand Seven Hundred Twenty Five Pesos (P 16,725.00) and was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

**WHEREAS**, the price quotation of the bidder was found to be substantially compliant:
