WHEREAS, during the Bid Opening last May 22, 2023, COPYLANDIA OFFICE SYSTEMS CORP., was declared Single Calculated Bid with the Bid amount of Twenty Eight Thousand Six Hundred Fifty Six Pesos (₱ 28,656.00) and was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;
