**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION  
AND RECOMMENDING APPROVAL FOR REPAIR OF CEILINGS AT VIP  
ENTRANCE, ARRIVAL GALLERY, AND CHECK IN-LOBBY AT ILOILO  
INTERNATIONAL AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP 2022-012-02 for the project **Repair of Ceilings at VIP Entrance, Arrival Gallery and Check-In Lobby at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Sixty One Thousand Nine Hundred Eighty Nine Pesos & 15/100 (₱ 161,989.15)** hereby form the integral part of this resolution. 
**NOW THEREFORE**, We, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.






