**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR FABRICATION AND INSTALLATION
OF SAFETY CRITICAL AREA SIGNAGE AT ILOILO INTERNATIONAL
AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2022-013-01 for the project **Fabrication and Installation of Safety Critical Signage at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Sixty Two Thousand Four Hundred Pesos (₱ 162,400.00)** hereby form the integral part of this resolution. - b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.


