**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL SUPPLY & DELIVERY OF SUPPLY &
DELIVERY OF MEDICAL & DENTAL AND DRUGS & MEDICINES FOR FY 2022
OF ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2022-023-01 for the project **SUPPLY & DELIVERY OF MEDICAL & DENTAL AND DRUGS & MEDICINES FOR FY 2022 OF ILOILO INTERNATIONAL AIRPORT** with Approved Budget for the Contract (ABC) in the amount of **Three Hundred Eighty Thousand Four Hundred Twenty Six Thousand & 38/100 Only (P380,426.38)** hereby form the integral part of this resolution. WHEREAS, two (2) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last June 17, 2022, **KENMART MARKETING** was declared Single Calculated Bid with the Bid Amount of **Three Hundred Seventy Nine Thousand One Hundred Forty One Pesos (P 379,141.00)**. **KENMART MARKETING** was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:




