RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING FOR THE APPROVAL OF SUPPLY AND DELIVERY OF OFFICE, IT, JANITORIAL, ELECTRICAL, OTHER SUPPLIES, CARPENTRY, COVID RELATED, DRUGS & MEDICINES, MEDICAL, DENTAL & LAB. SUPPLIES FOR CY 2022 AT GODOFREDO P. RAMOS AIRPORT

WHEREAS, BAC Resolution No. BSVP 2022-045-01 for the project **SUPPLY AND DELIVERY OF OFFICE, IT, JANITORIAL, ELECTRICAL, OTHER SUPPLIES, CARPENTRY, COVID RELATED, DRUGS & MEDICINES, MEDICAL, DENTAL & LAB. SUPPLIES FOR CY 2022 AT GODOFREDO P. RAMOS AIRPORT** with Approved Budget for the Contract (ABC) in the amount of **THREE HUNDRED SEVEN THOUSAND NINE HUNDRED SEVENTEEN PESOS & 67/100 ONLY (P307,917.67)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last September 23, 2022, **ILOILO IZEEM COMMERCIAL** was declared Single Calculated Bid with the Bid Amount of **THREE HUNDRED SEVEN THOUSAND FORTY PESOS ONLY (P307,040.00)**. **ILOILO IZEEM COMMERCIAL** was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, for the price quotations Bidder have substantially complied:
