**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF
EVAPORATIVE AIR COOLER FOR ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2022-049-01 for the **Supply and Delivery of Evaporative Air Cooler for Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount **Three Hundred Ten Thousand Pesos (₱ 310,000.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Three (3) interested supplier submitted their sealed quotation;

WHEREAS, Two (2) suppliers declared disqualified during the bid opening last November 2, 2022;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
