RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF PARTS OF 600W LED FLOODLIGHTS AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2022-050-01 for the project **Supply and Delivery of Parts of 600W LED Floodlights at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Four Hundred Three Thousand Pesos (P 403,000.00)** hereby form the integral part of this resolution. WHEREAS, Two (2) interested suppliers submitted their sealed quotations **WINEGARD CONSTRUCTION SUPPLIES TRADING and ILOILO EAST EMPIRE MERCHANDISING, INC.;**

WHEREAS, ; **ILOILO EAST EMPIRE MERCHANDISING, INC. was declared disqualified due to failure to submit their Tax Clearance as stated in the RFQ.**

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:


