



BAC Resolution No. BSVP 2023-002-02

RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING FOR THE APPROVAL OF SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES OF ILOILO INTERNATIONAL AIRPORT FOR THE PERIOD FEBRUARY TO MARCH 2023

WHEREAS, BAC Resolution No. BSVP 2023-002-01 for the project **SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES OF ILOILO INTERNATIONAL AIRPORT FOR THE PERIOD FEBRUARY TO MARCH 2023** with Approved Budget for the Contract (ABC) in the amount of **SIX HUNDRED NINETY-NINE THOUSAND SEVEN HUNDRED SEVENTY PESOS ONLY (P 699,770.00)** hereby form the integral part of this resolution. WHEREAS, three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last February 3, 2023, **ILOILO IZEEM COMMERCIAL** was declared Single Calculated Bid with the Bid Amount of **SIX HUNDRED NINETY-FIVE THOUSAND SEVEN HUNDRED SIXTY PESOS ONLY (P695,760.00)**. **ILOILO IZEEM COMMERCIAL** was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;
