**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF OFFICE
AND IT SUPPLIES FOR THE MONTH OF FEBRUARY-MARCH 2023 OF ILOILO
INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-004-01 for the project **Supply and Delivery of Office and IT Supplies for the month of February-March 2023 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Eighty Seven Thousand One Hundred Ninety One Pesos & 50/100 (₱ 187,191.50)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, two (2) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last March 2, 2023, **NEWTOWN MERCHANDISING, INC.** was declared Lowest Calculated Bid with the Bid amount of One Hundred Eighty Three Thousand One Hundred Sixty One Pesos & 75/100 (₱ 183, 161.75) and was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare, **NEWTOWN MERCHANDISING, INC.** as the Supplier with the Lowest Calculated Responsive Quotation **Supply and Delivery of Office and IT Supplies for the month of February-March 2023 of Iloilo International Airport** in the bid
