



BAC Resolution No. BSVP 2023-008-03

**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE
QUOTATION AND RECOMMENDING FOR THE APPROVAL OF SUPPLY &
DELIVERY OF DRUGS & MEDICINES AND MEDICAL & DENTAL SUPPLIES
FOR FY 2023 OF ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-008-01 for the project **SUPPLY & DELIVERY OF DRUGS & MEDICINES AND MEDICAL & DENTAL SUPPLIES FOR FY 2023 OF ILOILO INTERNATIONAL AIRPORT** with Approved Budget for the Contract (ABC) in the amount of **ONE HUNDRED NINETY-NINE THOUSAND EIGHT HUNDRED THIRTY-EIGHT PESOS & 50/100 ONLY (P199,838.50)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, two (2) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last April 4, 2023, **ECGA MEDICAL EQUIPMENT AND SUPPLIES TRADING** has been disqualified during the bid opening due to the following:

1. Non-submission of eligibility requirements as stated in the Request for Quotation: Special Power of Attorney for Sole Proprietorship/ Secretary Certificate for Corporation and Cooperative

In Section 30.1. of the 2016 revised IRR of RA No.9184 *“The BAC shall open the first bid envelopes in public to determine each bidder’s compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary “pass/fail” criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated “passed” for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed.”;*

2. Failure to attach additional Requirements as stated in the Terms and Conditions (Item No. 7):
 - Certification issued by the Department of Health (DOH) that has registered and complied with the requirement of uploading its data in the Electronic Drug Price Monitoring System (EDPMS);
 - License to Operate issued by the Food and Drug Administration (FDA) in accordance to RA 9711 “Food and Drug Administration (FDA) Act of 2009” and related issuances.
3. Bidder failed to indicate Expiry Date of Drugs and Medicines.
4. Bid Amount was not reflected in the RFQ.

WHEREAS, during the Post Qualification of Documents last April 14, 2023, Bids and Awards Committee (BAC) verified the documents and **FORSIGHT DISTRIBUTION INC.** complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder **FORSIGHT DISTRIBUTION INC.** was found to be the Single Calculated Responsive Quotation;

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, **FORSIGHT DISTRIBUTION INC.** as the Supplier with the Single Calculated Responsive Quotation **SUPPLY & DELIVERY OF DRUGS & MEDICINES AND MEDICAL & DENTAL SUPPLIES FOR FY 2023 OF ILOILO INTERNATIONAL AIRPORT** in the bid amount **ONE HUNDRED THIRTY-FOUR THOUSAND TWENTY PESOS PESOS ONLY (P 134,020.00)**;
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
