RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR REPAIR AND MAINTENANCE OF TAMARAW FX AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-012-01 for the project Repair and Maintenance of Tamaraw FX at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of One Hundred Twenty Five Thousand Two Hundred Fifty Pesos (P 125, 250.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, two (2) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last May 15, 2023, ILOILO FABRICATION SPECIALISTS INC. was declared Single Calculated Bid with the Bid amount of One Hundred Twenty Four Thousand Eight Hundred Thirty Five Pesos (P 124, 835.00);

WHEREAS, bid submitted by CASTLE ROO CAR SERVICES, has been disqualified during the bid opening due to: Annual Income Tax Return submitted is for the tax period Dec. 31, 2021 and received by the BIR on May 20, 2022, a non-compliance to GPPB NPM No. 009-2018 [see Sections 3.2 and 3.3 of Revenue Regulation (RR) No. 3-2005];

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, during the Post Qualification of Documents last May 24, 2023, Bids and Award Committee (BAC) verified the documents and ILOILO FABRICATION SPECIALISTS INC. complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, ILOILO FABRICATION SPECIALISTS INC. was found to be the Single Calculated Responsive Quotation;

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, ILOILO FABRICATION SPECIALISTS INC. as the Supplier with the Single Calculated Responsive Quotation Repair and Maintenance of Tamaraw FX at Iloilo International Airport in the bid amount of One Hundred Twenty Four Thousand Eight Hundred Thirty Five Pesos (P 124, 835.00);
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
